## Acknowledgement & Assumption of Risk

- I (and my child) understand the nature and dangers of Rugby activities and believe that my child is qualified to participate in RUGBY CLUB Activities. I further agree/warrant that if at any time I believe conditions to be unsafe, my child will immediately cease further participation in the RUGBY CLUB Activity.
- I (and my child) fully understand that: a) Rugby, like all sports, involve risks and dangers of **SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS AND DEATH** ("Risks"); b) these Risks and dangers may be caused by my or my child's own actions, or inactions, the actions or inactions of others participating in a RUGBY CLUB Activity, the condition in which a RUGBY CLUB Activity takes place, or the negligence of the "Releasees" named below; c) there may be other risks and social and economic losses either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR THE LOSSES, COSTS, AND DAMAGES incurred as a result of my child's participation in a RUGBY CLUB Activity.

## Parental Consent, Release & Indemnification

- I, the minor's custodial parent and/or legal guardian, understand the nature of the above referenced and am fully aware of the minor's athletic experience and physical capabilities and believe the minor to be qualified to participate in competitions and related activities organized by Alliance Rugby Club & Panther City Youth Rugby Club.
- I HEREBY RELEASE, DISCHARGE, COVENANT NOT TO SUE, AND AGREE TO INDEMNIFY AND SAVE AND HOLD HARMLESS ALLIANCE RUGBY CLUB & PANTHER CITY YOUTH RUGBY CLUB, ITS SPONSORS, AND ANY ORGANIZATION IT MAY BE AFFILIATED WITH, INCLUDING THE CITY OF FORT WORTH, TEXAS, along with their respective administrators, directors, agents, officers, volunteers, and employees, as well as other participants, any sponsors, advertisers, and, if applicable, owners and lessors of premises on which any RUGBY CLUB Activity takes place (each considered one of the "Releasees" herein) from all liability, claims, demands, losses, or damages on my or my child's account caused or alleged to be caused in whole or in part by the negligence of the Releasees or otherwise, including negligent rescue operations and further agree that if, despite this release, I or anyone on my child's behalf make a claim against any of the Releasees named herein, I WILL INDEMNIFY, SAVE AND HOLD HARMLESS EACH OF THE RELEASEES FROM ANY LITIGATION EXPENSES, ATTORNEY FEES, LOSS LIABILITY, DAMAGE OR COSTS ANY MAY INCUR AS THE RESULT OF ANY SUCH CLAIM.

## Agreement to RUGBY CLUB Rules / Policies

I understand that failure to follow stated rules / regulations may restrict my child's participation in RUGBY CLUB Activities including removal from such activities. ## Consent to Attain Medical Care & Medical Insurance Agreement
